- 1. Commissioner True called the Bexar County Emergency Services District No. 11 Meeting to Order at 6:17 P.M. and established a quorum with all five members present.
 - **a.** The Pledge of Allegiance was recited.
- **2.** Citizen Public Forum. (3-minute time limit per individual.) There weren't any citizens signed up to speak during this segment.

- 5. Discussion and update on the status of the 2_{nd} fire station within the District. The environmental study of the property showed that there was approximately 1,000 cubic yards of material consisting of concrete and bricks.

Motion carried by a 5/0 vote in favor.
- e. Authorization to pay DeMunbrun Scarnato Associates, Inc. for Architectural Services in the amount of \$7,814.56. Commissioner Herrera made a motion to authorize payment in the amount of \$7,814.56 to DeMunbrun Scarnato Associates, Inc. for architectural services. Commissioner Williams second the motion. Motion carried by a 5/0 vote in favor.
- 7. Authorization to amend the FY 2020 as discussed in the workshop. Commissioner Brown made a motion to amend the FY 2020 as discussed in the workshop. Commissioner Stevens seconded the motion. Motion carried by a 5/0 vote in favor.
- 8. Discussion and addition of any agenda items to be added to the next regularly scheduled monthly meeting. The next meeting is tentatively scheduled for March 19, 2020.
